ALL participants in the "Greetings!...from Debbie" service MUST agree to all terms and conditions of this contract in order to be eligible for participation. "Greetings!...from Debbie" is offered by Debbie Pelvit, Proprietor, hereafter referred to as Greetings!, while your business name will be referred to as the Participant. Upon approval by Debbie Pelvit, this agreement shall include the following:

- **Representation of Participant:** Greetings! is engaged in the service of greeting new residents and single professionals. Debbie Pelvit will represent the Participant by visiting with prospective clients within the \_\_\_\_\_ area. This application is also used for our other programs.
- **Service and Reports:** Greetings! will promote all Participating businesses during its home visitations; will promote the Participants' advertising message, and will present any promotional merchandise/samples or invitation cards to those home visitations made. Greetings! will make monthly reports to Participants, listing names, addresses, and phone numbers of those Clients presented information on behalf of Participant. Other demographic information will not be provided to participants.
- **Obligation of Participant:** Participant agrees not to rent, sell, or otherwise dispose of Client lists of names reported by Greetings! Participants will provide Greetings!, at its own expense, promotional merchandise, discount coupons, or other promotional materials necessary so that delivery to the Clients can be made when required. Participant will cooperate with Greetings! in making its service effective and profitable. Participant will defend the Greetings! program, its agents and employees and hold them harmless from all claims, damages, losses, and expenses including reasonable attorney's fees, with respect to any liability that is asserted against Greetings! and/or its proprietor (Debbie Pelvit) arising from the quality or character of any of its participants' services, products, advertising items, or samples.
- **Payment:** The Participant agrees to pay Greetings! for its services at the rate prescribed above per home visitation (depending on qualifications) pursuant to this agreement. Payment for services rendered by Greetings! shall be made upon receipt of invoice by Participant's check, payable to "Greetings!...from Debbie". A late payment fee of 1.5% will be assessed on all delinquent account balances. An account is considered delinquent if payment has not been received at the Greetings! office by the next invoice date.
- **Duration:** This contract will continue for a period of 12 months from the date of the contract and thereafter until either party shall have given the other party 90 days written notification prior to the expiration date. Similar notice shall be given by either party to the other in order to terminate this contract at the end of the 12-month period. The contract will automatically continue if no notice is given. - **Entire Contract:** This contract constitutes the entire understanding and agreement between the parties. It is subject to cancellation only as provided above and may not be altered or varied by oral agreements or representations of any kind.
